TERMS OF USE

Last Updated: March 1, 2024

This Terms of Use Agreement ("Agreement") constitutes a legally binding agreement made between you, whether personally or on behalf of an entity ("user" or "you") and Oregon Counselors and Therapists, Tracie McDowell, LPC and their affiliates (collectively, "we" or "us" or "our"), concerning your access to and use of the <u>www.oregoncounselorsandtherapists.com</u> and the Oregon C&T Listserv as well as any other media form or media channel related or connected thereto (collectively, the "Listserv").

The Listserv is hosted in the United States. We make no representation that the listserv is appropriate or available in other locations. The information provided on the Listserv is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject us to any registration requirement within such jurisdiction or country.
